LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The North Yorkshire Council (Reorganisation of Community Governance) Scarborough Order 2024

Made 26 Norman 2024

Coming into force in accordance with article 1

The North Yorkshire Council ("the Council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 24 July 2024.

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons, and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The Council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4) and 240(10) of the 2007 Act.

Citation and Commencement

- 1. (1) This Order may be cited as The North Yorkshire Council (Reorganisation of Community Governance) Scarborough Order 2024.
 - (2) Subject to subparagraphs (3) and (4) below it shall come into force on 1 April 2025.
 - (3) Article 9 shall come into force on the ordinary day of election of councillors in 2025.
 - (4) For the purposes of:
 - (a) this article;
 - (b) article 5; and
 - (c) proceedings preliminary or relating to the elections of parish councillors for the parish of Scarborough to be held on the ordinary day of election of councillors in 2025;

this Order shall come into force on the day after that on which it is made.

Interpretation

2. In this Order –

"County" means the county of North Yorkshire;

"Map" means the map marked "Map referred to in the North Yorkshire Council (Reorganisation of Community Governance) Scarborough Order 2024" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that numbers;

"New Parish" means the parish constituted by article 4;

"Ordinary Day of Election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983; and

"Registration Officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Constitution of a New Parish

- **4.** (1) A new parish, comprising the area outlined with a red line on the Map, shall be constituted within the County.
 - (2) The name of the new parish shall be Scarborough.
 - (3) The new parish shall have the alternative style of town.

Calculation of Budget Requirement

5. For the purposes of regulation 3 of the Local Government Finance (New Parishes) (England) Regulations 2008 there is specified in relation to the parish of Scarborough the sum of £384,000.

Parish Council for the Parish of Scarborough

- 6. (1) There shall be a parish council for the parish of Scarborough.
 - (2) The name of that council shall be Scarborough Town Council.

Elections for the Parish of Scarborough

- 7. (1) Elections of all parish councillors for the parish of Scarborough shall be held on the ordinary day of elections in 2025.
 - (2) The term of office of every parish councillor elected on the ordinary day of elections in 2025 for the parish of Scarborough shall be two years.
 - (3) There will be an election for councillors for the parish of Scarborough on the ordinary day of election in 2027 and every 4 years thereafter.
 - (4) The term of office for every parish councillor elected on the ordinary day of elections in 2027 for the parish of Scarborough will be four years.

Number of Parish Councillors for the Parish of Scarborough

8. The number of councillors to be elected for each of the parish of Scarborough shall be fifteen (15).

Wards of the parish of Scarborough and numbers of parish councillors

- **9.** (1) The parish of Scarborough shall be divided into 5 wards which shall be named as set out in column (1) of Schedule 1.
 - (2) Each ward shall comprise the area of the County specified in respect of the ward in column (2) of that Schedule and demarcated on the Map by orange lines.
 - (3) The number of councillors to be elected for each ward shall be the number specified in respect of the ward in column (3) of Schedule 1.

Annual Meeting of Parish Council

10. The annual meeting of the new parish council in 2025 shall be convened by the Assistant Chief Executive Legal and Democratic Services of the North Yorkshire Council. The meeting shall take place no later than 14 days after the day on which the councillors elected to the new parish council take office.

Electoral register

11. The Registration Officer for the County shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Transfer of property, rights and liabilities

12. The land, property, rights and liabilities described in Schedule 2 shall transfer from the Charter Trustees for Scarborough to the Scarborough Town Council on the date specified in column (2) of those Schedules.

Charter Trustees for Scarborough

13. Any functions which would have been exercisable in relation to the account of the charter trustees or as the case may be their responsible financial officer if the charter trustees had not been dissolved shall on and after the date of dissolution be exercisable by the parish council or as the case may be the parish council's responsible financial officer.

Transitional provision

14. Until the councillors elected to the council of the new parish of Scarborough at the elections to be held on the ordinary day of election of councillors in 2025 come into office, the new parish shall be represented by those persons who immediately before 1 April 2025 are the elected councillors for the North Yorkshire Council electoral divisions of Castle, Falsgrave & Stepney, Northstead, Weaponness & Ramshill, and Woodlands.

Order date

15. 1 April 2025 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by North Yorkshire Council for the new parish of Scarborough, created within the county of North Yorkshire.

The parish of Scarborough will be created with effect from 1 April 2025. The electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2025.

Article 7 provides for parish elections in the parish of Scarborough in 2025 for a 2 years term, with ordinary elections then taking place in 2027 and continuing according to the established system of parish elections every four years.


Article 8 specifies the numbers of parish councillors for the new parish of Scarborough.

Article 9 and the map establish the names and areas of the wards of the new parish of Scarborough and the numbers of councillors for each ward.

Article 11 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

The map defined in article 2 shows the new wards of the parish of Scarborough. It is available, at all reasonable times, at the offices of North Yorkshire Council.
