Wycombe District Council (Reorganisation of Community Governance) Order 2019 ("the Order")

Coming into force in accordance with article 1(2) of the order

Wycombe District Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 4 December 2018:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The council makes the following Order in exercise of the powers conferred by sections 86 (2) of the 2007 Act.

1. Citation and commencement

(1) This order may be cited as the Wycombe District Council (Reorganisation of Community Governance) Order 2019.

(2) It shall come into force on 1st April 2019. **2 Interpretation**

(1) In this Order-

- "district" means the district of Wycombe;
- "existing" means existing on the date this Order is made;
- "map" means the map marked "Map referred to in the Wycombe (Reorganisation of Community Governance) Order 2019 and deposited in accordance with section 96(4) of the 2007 Act: and any reference is a reference to the sheet of the map which bears that number;
- "Registration officer" means an officer appointed for the purpose of, and in accordance with, section 8(C) of the Representation of the People Act 1983.

3. Effect of Order

(1) This order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

4. Alteration of Bledlow cum Saunderton Parish Council Boundary and Lacey Green Parish Council Boundary

(1) The area coloured red and designated by the letter "A" on the map shall cease to be part of the parish of Lacey Green and shall become part of the parish of Bledlow cum Saunderton.

5. The number of parish councillors for Bledlow cum Saunderton parish and Lacey Green parish

(1) The number of councillors to be elected for the parish of Bledlow cum Saunderton parish and Lacey Green Parish remain unaltered

6. Electoral Register

(1) The electoral Registration Officer for Wycombe District shall make such rearrangement of. Or adaption of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this order.

(2) Three properties are affected, namely Bottom Field Cottage, Ridgeway Lodge and Shootacre House.

7. Order date

(1) 1 April 2019 is the order date

8 Commencement date

(1) The Order comes into effect after the day it is made
